INTRODUCTION

The Portuguese Society of Authors (SPA) is a limited liability cooperative, established in 1925 with the purpose of defending the rights and interests of the authors it represents through collective management. At the present time, the Portuguese Society of Authors is the representative in Portugal of rights' holders from all over the world since, in addition to the works it manages directly, it has reciprocity agreements with sister societies, empowering it to safeguard the rights of foreign authors. Therefore, by granting licences for the public performance of musical works, SPA is authorising the use of works both from Portuguese and foreign authors.

One of SPA's key roles is to grant licences for different types of use of musical works and to collect a compensation fee in return. In fact that compensation fee represents the remuneration that an author is entitled to for any use of his/her works.

Whenever an author creates a musical work, he/she is automatically entitled to use or authorise the use of his/her work by third parties. The authorisation that may be granted by the author may or may not imply (depending on the author's wishes) the payment of an amount considered appropriate by the author. The amount established by the author therefore represents the payment to which he is entitled for the use that will be made of his works.

By acting on behalf of the authors, this right to authorise the use of the works will be exercised by SPA, as well as to establish the amount to be paid as compensation for the use.

The present tariffs were elaborated taking into the consideration the above mentioned principles, in order to strike a balance between SPA's fundamental activity, to protect the interests of authors, on one hand, and because of the multiple circumstances and uses of a creative work, to organise the types of users and fees, through objective differentiation, thus ensuring greater consistency.

Public performance includes all sounds and performances rendered audible to the public in any place, by any means and in anyway whatsoever, whether the said means are already known and in use, whether hereafter discovered and put to use. This includes therefore all auditions and performances provided by live means, instrumental or vocal, by mechanical means, such as phonographic records, microphones and sound tracks (magnetic or otherwise).

GENERAL RULES

1. TYPES OF USE

The licences are granted for each type of use, such as Dancing, Shows, Fado, Karaoke, resident DJ's, Popular Music Concerts (bands, musical groups, artists and DJs), Fashion Shows, Background Music, Exhibition of Videograms, Public Communication of Cable or Satellite Television.

2. TARIFF AGGRAVATION

- > The value defined in the Minimum Tariffs for the licencing of public performance rights are valid for all performances whose rights are settled in advance. Thereby the monthly licences have to be paid before the beginning of the corresponding month and the annual licences in the first business day of the calendar year.
- > All payments made after the performances are aggravated by 20% (art. 68, paragraph 3) and art. 41 paragraph 3)) of CDADC, as approved by Decree-law 63/85, of 14th March, amended by Law 45/85 of 17th September).

3. TYPES OF VENUES

- > The Minimum tariffs for Public Performance Rights are applied according to the categories defined in 3.1 hereafter.
- > The categories are attributed according to the business activity, capacity and/or area, as well as business hours.

3.1 Restaurants and similar with dancing premises

- > The minimum fee applied to this category depends on the capacity of the venue.

3.2 Hotels and similar

- > For activities performed in the premises of hotel units, such as bars, restaurants, nightclubs, congress halls, the minimum tariff for each venue is applied, taking into consideration the following:
- > For essential music performed at bars and restaurants of the hotel, with a dancing venue, Tariff 1 is applied. Without dancing, Tariff 2 is applied.
- > For essential music performed in Congress Halls or Auditoriums, Tariff 5 is applied.
- > For essential music performed in garden areas of the hotel, Tariff 9 is applied.
- > For essential music performed at the lobby or other common areas with dancing applies Tariff 1. Without dancing, Tariff 2 is applied.
- > In case of facilities under concession to third parties, applies Tariff 5, and the concessionary is responsible for the payment of the rights of author.
- > For Audiovisual and Background music performed in common areas at hotel premises, such as restaurants, bars, congress halls Tariff 4 is applied, taking into account the category of the hotel.
- > If the venue is under concession to third parties, it is applied the corresponding tariff to each one of the venues or areas, and the concessionary is responsible for the payment of the rights of author.
- > For Audiovisual broadcasted in the hotel rooms, an effective occupancy rate of 35% of the total number of rooms is taken into consideration, provided the payment is made prior to the use of the works.

3.3 Other types of venues

- > All other venues where there is public performance of protected works are classified according to its designation and the maximum capacity assigned.
- > The capacity is determined by the number of occupants or available space in public areas, considering 0,50m2 for standing positions and 0,75m2 for sitting positions.
- > For other venues not included in the list, Tariff 8 is applied for indoor premises and Tariff 9 to outdoor premises.

3.4 Single/ casual events

- > In the event the venues listed under Tariffs 1 and 2 arrange for single/ casual events, Tariff 7 is applied.

3.5 High capacity venues

- > In case of events where the capacity of the premises is higher than established in the tariffs, a 10% surcharge is applied per range, according to the last entry of the corresponding table.

4. **ESSENTIAL MUSIC** – *refers to the use of music in places whose operation depends on its use by public performance*

4.1 Dancing venues

- > The tariffs for all establishments with dancing venues are defined in the table.

4.2 Popular Music Concerts and Rave parties: any live or recorded music show with the performance of an artist, band or musical group or any event where such performances are the main attraction.

4.3 Background music and DJs

> Background music is all use of musical works in public places to set the ambiance, without a dancing venue or a DJ cover.

> A resident DJ is in charge of performing music in the establishment during the business hours and is part of the staff. A guest DJ is invited to perform occasionally.

4.4 Paid admission shows

> In all activities with paid admission, the tariffs will be calculated as follows:

> Dancing, Concerts, Rave Parties, Variety Shows, Fado concerts etc. - 5% on the receipts corresponding to the venue's full capacity, with the Minimum tariffs applicable according to the venue (ticket price x full capacity x 5%).

> For nightclubs, bars and other establishments with minimum consumption policy, 50% of the admission amount is taken into account in order to determine the payable tariff.

> For live or recorded music shows, with capacity over 1000 seats, **in the 48 hours prior to the event**, licensees may choose to settle a 10% payment of the box office receipts **plus 150 euros per show**, for the inspection fund, according to the applicable minimum tariff. The box office sheet must be submitted to SPA on the business day following the event.

> In this case, it is mandatory to make a deposit equal or superior to the regular collection amount (5% over the full capacity of the venue), which shall be activated 48 hours after the event.

4.5 Carnival Holidays (from Saturday to Tuesday) and New Year's Eve

> For all essential music use, without paid admission, the tariff is double the amount of the licences referred in the Minimum table, per each day.

> In case of paid admission, the collection is made according to 4.4 above.

4.6 Events without Paid admission – Capacity Over 15,001 seats

> For all events without paid admission fee and with a capacity of more than 15,001 seats, the promoter must present the event's production costs, not including taxes. A percentage of 5% will be charged on these costs, **in case they are superior to the minimum tariff set out in the Tables.**

Production costs include all the expenses necessary to organise the show, namely expenses related to setting the stage, sound equipment and technicians, lighting equipment and technicians, artists' fees, accommodation and travel expenses, subsidies or sponsorships in the form of financial contributions, police and security.

5. CINEMA EXHIBITION

For musical works included in movies (soundtracks), the collection is made per cinema session, in accordance with the tariffs for the exhibition of videograms.

SPA reserves the right to collect the payment for other types of works, namely the audiovisual works.

6. ANNUAL LICENSES

The annual licences are in general 12 times the monthly amount.

There is a 10% discount applicable to payments settled prior to the use of the works.

7. MINIMUM COLLECTION TARIFF

All licences whose amount is inferior to 30 euros are subject to quarterly payment.

8. VALUE ADDED TAX (VAT)

The amounts referred to in the tariffs might be subject to VAT at the legal rate in force.

9. SET LISTS FOR LIVE MUSIC SHOWS

According to article 122 of the Portuguese Copyright Code and Neighbouring Rights, the promoter of a public show is obliged to deliver a copy of the set list including the title of the works, the rights holders or its legal representative (SPA).

10. LARGE SCREENS AND LARGE VENUE PROJECTORS

The use of large screens and large venue projectors for the Public Communication of videograms or cable/satellite television in single / one-off events is subject to a payment of twice the amount of the daily tariff in accordance with the table for exhibition of videograms. The monthly and annual tariffs do not apply.

11. DISCOUNTS

Discounts are non-cumulative, except in case of advance payment of the annual license, and is only applied the highest discount to which the user is entitled.

12. REFUNDS

The amounts collected for the monthly and annual licences are not refundable, regardless of the effective use of the works (cancellation or re-schedule).

13. LICENSE SCOPE

The daily license is valid per session, even if it extends past midnight.

For events extending over consecutive days, the license is valid per session and until 12h00 am.

14. PUBLIC UTILITY

All users considered public utility benefit from a 10% discount over the tariff, provided the payment of the license is settled in advance.

TARIFF 1

Drinking establishments, Restaurants and similar with dancing venues

This tariff applies to businesses that offer food and/or beverage services in premises with dancing venues, such as Nightclubs, Bars, Restaurants, Pubs, Variety, Discotheques, Clubs.
